Artur GRUSZCZAK – Associate Professor of International Relations (Faculty of International and Political Studies, Jagiellonian University); Associate Fellow at the European Centre Natolin in Warsaw, Coordinator of Forum “EU Justice and Home Affairs”. Member of TEAM EUROPE, a group of experts on European integration established by the Delegation of the European Commission in Poland; member of the Contributors’ Group of Statewatch in London. In 2009-2010 head of Group of Experts on the protection of fundamental rights in the EU area of freedom, security and justice advising Polish Ombudsman. Visiting Fellowships in Vienna (1994), Bogota (1996), São Paulo (1997), Madrid (1998), Rochester, NY (2002); ERASMUS Visiting Professor in Bergen (2009), Murcia (2010) and Barcelona (2011). Member of International Political Science Association (IPSA); American Political Science Association (APSA); International Studies Association (ISA); Central and East European International Studies Association (CEEISA); European Union Studies Association (EUSA). Main interests and research areas include: strategic studies; security governance; European intelligence cooperation, privatization of security; justice and home affairs in the European Union. Author of nine monographs (four as co-author), 60 chapters and 40 papers. His texts were translated into Polish, English, Spanish, Portuguese, Chinese and Czech and published in Poland, Germany, the US, the UK, the Netherlands, the Czech Republic, Serbia, Colombia, Brazil and Costa Rica.

Dr. Marcin MARCINKO – Senior Teaching and Research Assistant (Chair of Public International Law, Jagiellonian University); coordinator of the International Humanitarian Law and Human Rights Centre, Jagiellonian University; member of the National Commission for International Humanitarian Law of the International Humanitarian Law Dissemination Centre at the Polish Red Cross Main Board; member of the International Law Association – Polish Group; winner of the Stanisław Kutrzeba Competition on the Protection of Human Rights in Europe, scholarship holder of the Max Planck Institute for Comparative Public Law and International Law in Heidelberg (2005-2006); since 2001 he has cooperated with the Institute for Strategic Studies in Kraków; his academic interests concern international law, international security, (former) 2nd and 3rd pillar of the EU and contemporary armed conflicts; author of numerous publications relating to the issues of fight against terrorism in international law (doctorate title – *United Nations facing the Phenomenon of Contemporary International Terrorism*) and issues concerning international humanitarian law of armed conflicts.

Description

The main objective of the course is to introduce students to both basic and more detailed topics related to the EU Member States’ cooperation in fields of administration, justice and home affairs. The course is composed of two major parts:

- In the first (taught by Dr. Marcinko), main emphasis will be put on selected aspects of EU contribution to the Europeanisation of public administration and civil services of Member States. This main stream of consideration will be illustrated by some essential examples, such as the functioning of national regulatory authorities, operation of administrative rules

and procedures in implementation and enforcement of EU law and policies. Regulations on civil services in selected EU Member States will too come under analyses.

- The second part (taught by Prof. Gruszczak) is dedicated to the creation and functioning of the EU area of freedom, security and justice – since the emergence of Justice and Home Affairs cooperation in its historical context, through the evolution of Member States' activity and cooperation within that area until the post-Lisbon changes. A detailed description and analysis will concern such areas as migration and asylum policies, border management, Schengen governance, EU internal security strategy, criminal justice (police cooperation, prevention and the fight against crime, and judicial cooperation in criminal matters). The roles and competences of EU institutions and agencies, esp. those in the JHA field: Eurojust, Europol, Frontex, will be presented during the classes, together with major institutional developments in terms of strategies, action plans and Council conclusions.

COURSE ORGANIZATION

Both lectures and seminars will be held during the course. Theory will be taught during lectures, while seminars will have a more practical character – students will be expected to take active part in seminar discussions and to study and resolve problems contained in historical or hypothetical legal cases. In addition, some reading materials will be distributed during the classes.

Assessment

Students are expected to attend the classes and to take active part in seminar discussions. Students will be asked to prepare two brief presentations (10-15 minutes) for each of the two main areas of the course. While some topics will be suggested by the lecturers, students are encouraged to come up with own ideas for presentations, with the understanding that they fall within the course subject-matter. In order to prepare presentations students may be required to do some individual research.

The grading will depend on the results of the final exam composed of a multiple-choice test of 30 questions and 10 short-answer questions (50%). Class presentations (15% + 15%) and the general performance during the seminars (20%) will also influence the final grade.
